Foundation Donates Masks to Campus

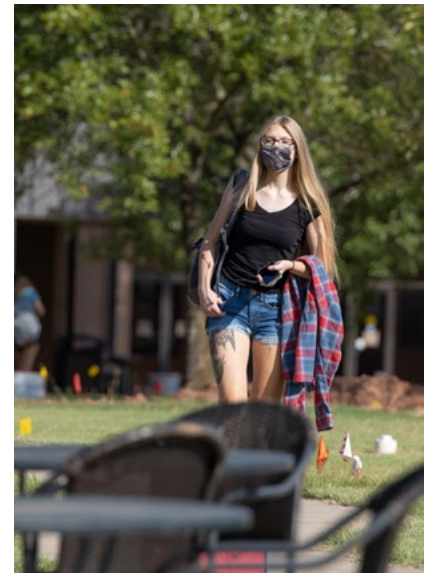

SSC Names COVID-19 Officer

At the beginning of the fall semester, Seminole State College selected Dr. Deanna Miles to serve as the campus's COVID-19 Officer.

Dr. Miles most recently served the College as an Assistant Professor in the Science, Technology, Engineering and Math (STEM) Division and a Curriculum Specialist through a Title III grant.

"I'm excited to serve as the COVID-19 Officer. It's a challenge, but we're doing everything we can to get students and employees what they need to make everyone safer," Dr. Miles said.

Dr. Miles received her Bachelor of Science from Baylor University in Waco, Texas. She then completed her Medical Doctorate at the University of Oklahoma and she also completed her Master's Degree in Healthcare Administration at Grand Canyon University in Phoenix, Ariz..

As someone who grew up in Moore, Okla., Dr. Miles is no stranger to adversity. On May 3, 1999, her parents' medical clinic was hit by an F-5 tornado. She learned from watching her parents and those around her respond and rebuild in a time of crisis.

"I remember moving the phone lines to our home, trying to get prescriptions to people in need. While this health pandemic is obviously a very different scenario, dealing with the tornado gave me more experience to handle these challenging times than I even realized," Dr. Miles said.

One of the first tasks Dr. Miles undertook in her new role was helping campus administrators and staff from several different departments compile a COVID-19 Safety and

Procedure Manual. The manual is regarded as a living document and will be updated when necessary. It includes information on sanitization, workplace accommodations, what do when you or someone you have been in contact with has tested positive and many other topics.

"I've been really impressed by our professors. They've been really great about sanitizing classrooms and reinforcing what steps need to be taken to their students," Dr. Miles said.

When walking around campus, Dr. Miles has found most people following preventative measures. "At times I'll see a few overlooking things—they aren't staying six feet apart, maybe their masks are positioned under their noses, but for the most part everyone seems to be doing a

good job."

To improve accuracy in contact tracing, SSC has developed seating charts for each course that meets face-to-face and added a reporting form to the top of its website, sscok.edu. Students, faculty and staff are encouraged to fill out the form if they test positive for COVID-19, if they develop symptoms and are in quarantine until they get COVID-19 test results back, or if they are a first-degree contact with a person who is confirmed positive.

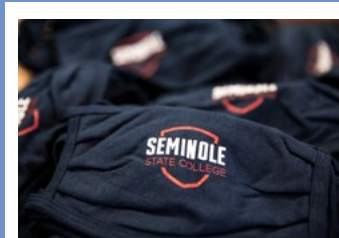
SSC President Lana Reynolds said Dr. Miles will be continually reviewing SSC protocols and responses to COVID-19-related issues.

"We feel very fortunate to have someone with Dr. Miles experiences in the medical field, as well as

the classroom, to provide guidance to us during this time. She will also serve as a liaison with the Seminole County Health Department and the Oklahoma Department of Health in reporting positive test cases and monitoring campus exposures," Reynolds said.

SSC Hires New Chief of Police

Former Seminole Chief of Police Shane Marshall was recently named Chief of Police for the Seminole State College Police Department. Marshall brings with him more than 25 years of law enforcement experience.

Since 2018, Marshall has served as a full-time officer for the College's Police Department. In that role, he assisted the campus by training department personnel, students and employees with emergency preparedness and safety. He also helped the department maintain twenty-four-hour coverage of the campus, facilities, students, staff and guests.

Marshall retired from the Seminole Police Department in 2016. He began as a Dispatcher/Reserve Officer in 1993 and after three years became a Patrol Officer. In 2002, he was promoted to Detective where he served for the next 8 years until he assumed the role of Police Chief in 2010. During his time as a law enforcement officer, Marshall obtained over 1200 hours of continuing education credits and training, including executive level training at Arkansas Leader in Little Rock, AR, Rural Executive Management Institute in Chicago, IL and New Chiefs Training in Oklahoma City, OK.

Marshall was born and raised just east of Seminole and graduated from Butner High School. He took concurrent classes at SSC and went on to get his bachelor's degree in criminal justice from East Central University. He has been a lifelong resident of Seminole where he and his wife

Heather have raised their four boys, Kolten, Kendell, Bryce and Jordan.

Vice President for Student Affairs Dr. Bill Knowles said, "Shane has been a valuable member of our SSC community and his experience and training will be an asset for our students and employees. His wealth of police knowledge will help convey the importance of safety and security as we continue to update and improve these efforts on our campus."

Marshall replaces Louis Ross, who held the SSC Chief of Police position since July of 2017. Ross recently accepted the position of Chief of Police at Rogers State University in Claremore.

Pitts Appointed to SSC Board of Regents

Ryan Pitts, J.D., was recently appointed to the Seminole State College Board of Regents by Governor Kevin Stitt. Pitts will serve from July 27, 2020 to July 1, 2023. He is completing the remainder of former Regent Paige Sherry's term. Sherry stepped down in the spring when her husband, Jack Sherry, was appointed to the Oklahoma State Regents for Higher Education to avoid a conflict of interest.

"I am deeply honored to have been appointed a regent to Seminole State College. I look forward to working with the faculty and staff to serve this region and the State of Oklahoma," Pitts said.

Pitts resides in Wewoka. Since April of 2019, he has been the owner and senior attorney at the Law Offices of Ryan H. Pitts, P.C., where his practice focuses on civil litigation and transactional law. From 2013 to 2019, he worked as an associate attorney at Harold Heath Law Offices P.C. in Holdenville. He also serves as a municipal judge for the city of Holdenville.

Pitts received his Juris Doctorate from the Oklahoma City University School of Law in 2013, his Master's Degree in Human Relations from the University of Oklahoma in 2010 and Bachelor of Arts in Political Science from the University of Oklahoma in 2007.

Since 2015, he has also managed Newman Ranches, a cow-calf operation, in Sweetwater, Texas. He enjoys cultivating the land and manages the payroll and books.

He also assists with the facilities and food preparation for the annual reunion of the National Women's Airforce Service Pilots World War II Museum in Sweetwater, Texas.

SSC Welcomes Presidential Leadership Class XIV

Seminole State College has chosen 18 students for Class XIV of the SSC Presidential Leadership program. PLC is a two-year scholarship program created to help students develop leadership skills and provide personal and professional growth opportunities.

“The Presidential Leadership Class provides students with unique opportunities to foster their leadership skills while developing academic growth,” SSC President Lana Reynolds said. “We look forward to working with these outstanding students. They will have some great opportunities throughout the year to meet with state leaders, learn about state government and philanthropy, study leadership styles and volunteer their time.”

The scholarship program was established to provide educational classroom and extracurricular activities to enhance leadership skills of students. Responsibilities of PLC members include volunteering for community service programs and campus events.

School officials throughout the College’s service area of Seminole, Lincoln, Pottawatomie, Hughes and Okfuskee counties are invited by President Reynolds to nominate high school seniors as candidates for the scholarship program each December. Other students are nominated by business owners and school officials. Participants are selected based on ACT scores, academic performance in high school and demonstrated leadership ability.

SSC Awarded \$2.86 Million in Federal Grants

The U.S. Department of Education recently awarded Seminole State College two grants totaling approximately \$2.86 million. The College was officially notified of the awards Aug. 7 by the offices of U.S. Senator James Lankford and U.S. Congresswoman Kendra Horn.

The programs receiving the grants are Student Support Services (SSS) and Science, Technology, Engineering, and Mathematics Student Support Services (STEM SSS). Beginning this September, SSS will receive \$294,725 annually for the next five years. STEM SSS will receive \$261,888 annually for the next five years.

The grant application process was spearheaded by SSS and STEM SSS Director Janna Wilson-Byrd. Retired SSC Director of Sponsored Programs Kathy Hoover served as a consultant during the proposal process.

“The success of the SSC Student Support grants lies in teamwork. Everyday our professional staff team, which is made up of Laura Votaw, Sarah Ledford, Damon Cravens, and Kristen Bean, work toward the same mission of assisting our SSS participants in academic success. A special thank you goes to Kathy Hoover for providing rare expertise with her consulting services during the writing process. Finally, I am grateful for the SSC administration, led by President Reynolds, for giving full support to write for the 2020 Student Support Services competition as well as the commitment to SSS programs for the next five years,” Wilson-Byrd said.

Both grants serve first-generation, economically disadvantaged, and disabled students. The purpose of the grants is to support these students in post-secondary persistence, completion and transfer.

Services provided by the grants include tutoring, academic advising, group study/tutoring, financial literacy, financial aid assistance, transfer assistance, dedicated study/computer labs, university visits and cultural events.

“These grants provide valuable services to our students – many

times giving them the support they need to attend and complete college. We are very appreciative of our Congressional delegation, particularly Senator Lankford and Congresswoman Horn, for working with the U.S. Department of Education to bring these dollars home to Oklahoma,” President Lana Reynolds said.
