**Important Information for all benefits:**

- **It is your responsibility to report any changes in your schedule and/or major to the Veterans Services Office.** Changes not reported could cause an overpayment of benefits that you will be responsible for returning to the VA later (including BAH overpayments due to a reduction in total hours).
- I understand that the Veterans Coordinator **will not certify classes that are not on my degree plan** and I will be responsible for the payment of these courses.
- The VA will process your certification in approximately 2-4 weeks. The VA generally pays on the last day of each month.
- For Post-9/11, you will receive your BAH and book stipend in 2-4 weeks. **SSC sends tuition and fee information to the VA after the drop/add period ends**, so no payment will be reflected on your bursar account before then.
- Submit a copy of your **Certificate of Eligibility** at your earliest convenience. Failure to provide COE could result in delayed benefits
- If a student is denied benefits from the VA or DoD, **classes must be dropped before the end of the refund period.** Students will be responsible for any charges after the refund period.
