



The Seminole State College Nursing program recently partnered with The Medicine Shoppe in Shawnee to administer COVID-19 vaccinations to hundreds of people. Under the direction of SSC Nursing Instructor Sheryl Denton, several nursing students have volunteered at the pharmacy.

"The students have done an outstanding job giving around 100 injections a day to the public," Denton said

Students have been eager to lend a

hand with the vaccination process. Many of the students gave up time during Spring break to assist with injections.

"This effort speaks volumes about the type of dedicated, caring nursing students we have at Seminole State College," SSC Nursing Program Director Crystal Bray said.

To date, the nursing students have administered more than 850 injections to the citizens of Shawnee and surrounding areas.

#### SSC Women's Basketball Team Wins Conference Championship

The Seminole State College Belles women's basketball team won the Oklahoma Collegiate Athletic Conference title game on April 1. Pre-season predictions placed Seminole State College at sixth in Region II. The Belles demonstrated great effort and resolve as they battled tough competition. During the second half of conference play, the team gathered steam with each subsequent win and entered their final conference game with a nine-game win streak. Seminole

State defeated NOC-Tonkawa 78-62 to solidify their first-place position. The Belles finished as regular season conference champions, a far cry from their initial sixth place seating. The last time the women's basketball team brought home a conference championship was 2007.

The Belles will enter the Regional tournament with a conference record of 12-3 and 15-4 overall.



# SSC to Launch Mobile Enrollment Events Later This Month



Seminole State College will host four mobile enrollment throughout the College's service area in the month of April.

Seminole State College will host mobile enrollment events in Shawnee, Prague, Okemah and Holdenville throughout the month of April. These events are for summer and fall enrollment. An academic advisor, an admissions representative and a recruitment specialist will be present to answer questions and guide perspective students through the enrollment process. There is no minimum GPA or ACT score required for admission.

"We wanted to simplify the process for students across our service area. These events bring the enrollment process directly to anyone interested in higher education. Current and perspective students will be able to apply, meet with an advisor and enroll – all in one short visit," SSC Vice President for Student Affairs Dr. Bill Knowles said.

The first of these mobile enrollment events will take place at Gordon Cooper Technology Center in Shawnee on April 12 from 10 a.m. to 2:30 p.m. SSC staff will be setup in Skylab 1 and 2 on the GCTC campus.

On April 16, SSC will hold a mobile enrollment event at Ken's Pizza in Prague from 10 a.m. to 2:30 p.m.

SSC staff will then help students with enrollment at BancFirst in Okemah on April 19 from 10 a.m. to 2:30 p.m.

The final event will take place at the Grace M. Pickens Library in Holdenville on April 23 from 10 a.m. to 2:30 p.m.

Anyone interested in applying is encouraged to bring their high school transcript and college transcript, if applicable. The summer semester begins May 10 and the fall semester begins August 16.

#### **PLC Attends Virtual Higher Ed Day**

Members of the Seminole State College President's Leadership Class attended a Virtual Higher Ed Day on March 9 in the Enoch Kelly Haney Center. The event featured four members of the Oklahoma State Legislature - Senator Zack Taylor (R- District 28), Senator Shane Jett (R-District 17), Representative Danny Williams (R- District 28) and Representative Dell Kerbs (R- District 26). The speakers spoke with students through video conferencing software, informing them of the current legislative session and answering their questions.

Higher Ed Day is generally held at the State Capitol annually. In an effort to safeguard community health, the event was held virtually this year. The event allows legislators to connect with campus and community leaders to share the value higher education has on workforce development and economic growth.

Senator Taylor was first elected to the state Senate in 2020 to represent District 28, which includes communities in Lincoln, Pottawatomie and Seminole counties. The Seminole Republican first served as a member of the Oklahoma House of Representatives from 2017-2019.

Senator Jett assumed office on Nov. 16, 2020. He serves District 17, which includes northern Pottawatomie County and eastern Oklahoma County. Previously, Senator Jett served six years in the Oklahoma House of Representatives, becoming the first Republican to represent District 27.

Rep. Williams is a member of the Oklahoma House of Representatives, representing District 28. He assumed office on Nov. 16, 2020. He is from Seminole and represents Pot-

tawatomie and Seminole Counties.

Rep. Kerbs represents District 26 in the Oklahoma House of Representatives. He first assumed office on Nov. 16, 2016 and was re-elected in November of 2020. He is from Shawnee and represents Pottawatomie County.

## Students Complete Peer Mentor Certification

Sierra Josselyn and A-yo Jones, two Seminole State students, recently completed qualifications for a national certification in peer mentoring from the Peer Leader Center. Both students are employed by SSC Student Support Services as peer mentors. In their positions, they help guide peers in navigating college, meeting other students, developing basic academic skills and discovering important resources. Josselyn and Jones are the first two students at the college to achieve the certification.

The certification is achieved by completing an eight-hour online course and practicing elements of peer mentoring skills with students. The SSS Director, Janna Wilson-Byrd, then validates the completed work of the peer mentors to the Peer Leader Center. The topics in the course align with the College Reading and Learning Association's recommendations under their Level 1 mentor training certification.

The course includes 14 learning modules and includes reading, activities, scenario practice, quizzes and a

video bank to introduce knowledge and skills in several competency areas. Examples of the competencies include: Understanding the Peer Mentor's Role, Building Communication Skills in Listening and Asking Questions, Preparing Students to Study through Academic Coaching, and Developing a Safe Space. There are 10 total competencies.

"I could not be prouder of Sierra and A-yo. Both of these outstanding students saw this certification as an opportunity to improve their skills. They never saw it as a burden to their academic studies. They accepted the challenge to take on the extra work so they can become the best leaders and helpers for their peers. It is an honor to present them as the first certified peer mentors at SSC. Our ultimate goal is for our Peer Mentors to assist our new program participants with overall success in acclimating to college. Successful college navigation often leads to successful college completion. Sierra and A-yo will have a hand in helping students succeed," Wilson-Byrd said.

## **SSC Board of Regents Grants Tenure to Faculty Member**

The Seminole State College Board of Regents met March 25 to grant tenure to Business and Education Professor Chunfu "Jeff" Cheng, to reaffirm the Board's commitment to opposing the presence of firearms on campus and to review a bid to replace the heat and air unit for the Raymond Harber Field House.

The meeting opened with the presentation of a plaque to The SSC Belles women's basketball team in recognition of their 50th season. Belles head coach Rita Story-Schell and sophomore guard Kryslyn Jones of Edmond were present at the meeting to accept the recognition.

The plaque read, "Presented in recognition of providing trail-blazing opportunities for women in sports, bringing pride to the institution with a National Championship victory and an ongoing commitment to excellence on and off the court."

SSC President Lana Reynolds then presented her President's Report, which included an update on the College's personnel changes, campus activities, snowstorm damages and repairs, reports on the decrease in the number of COVID-19 cases and vaccination efforts. She also discussed plans for the 2021 Commencement exercises. At present, the College will limit attendance at graduation to students, faculty and staff in an effort to meet social distancing guidelines. The event will be livestreamed for family and friends of the graduates.

The first action item was the recommendation to grant tenure to Business and Education Professor Chunfu "Jeff" Cheng. Cheng has been employed by SSC since 2011. In that time, he has served as an instructor, the Business and Education Division Chair, Faculty Senate President and

as the Phi Theta Kappa Honor Society Advisor. He is currently pursuing a Doctor of Education at Northeastern University in Boston, Mass. Following the review of his application materials, the Board approved his tenure status.

The second action item was the reaffirmation of the College's ban on firearms on campus. The reaffirmation was a response to the Oklahoma State Regents for Higher Education's request to a commitment against allowing firearms on campus to help counter any proposed legislation that amends current law. With the third action item, the Board approved the removal of Policy III-4-2 regarding Financial Disclosure statements. The policy, adopted in 2000, required Board members and administrators to complete financial disclosure documents and make them available to the Oklahoma Ethics Commission. The Commission's rules changed in 2016. The College's legal counsel in the Oklahoma Attorney General's Office informed the Board that financial disclosures are no longer required except for elected officials and judiciary subject to retention.

The Board then tabled the fourth action item, a bid to replace the heat and air unit for the Raymond Harber Field House. The College will seek additional bids, and the Board will make a decision at a later meeting.

Next the Board approved the process to seek \$875,000 in financing through the State of Oklahoma's Master Lease Program to address other major maintenance projects on campus. The projects to be addressed with this funding include parking lot repairs, replacement of the Raymond Harber Field House roof and renovation of the natatori-

um area where the pool was located.

Bids were considered and awarded to A-Tech Paving for \$448,695 for parking lot repairs and Silver Star for \$93,684 for renovation of the natatorium. An item to consider bids for roof replacement in the Raymond Harber Field House was tabled.

Board members present at the

meeting were: Chair Curtis Morgan, Bryan Cain, Marci Donaho and Kim Hyden.

The next SSC Board of Regents meeting is set for Thursday, May 20, 2021.
